- 2. Board Member Recognition** Pat Bryant announced that Jeff Fitterling will be honored on May 2<sup>nd</sup> at District Appreciation Night but also wanted to publicly thank him, at this time, for his service the last three years as a board member and an advocate for students. She also thanked him for his contributions to the Pattonville Education Foundation.
- 3. Certification of Election Results** Ralph Stahlhut moved that the Board of Education approve as true, complete, and correct, the abstract of votes cast on Tuesday, April 5, 2005, pending certification by the Board of Election Commissioners of St. Louis County, Missouri. - 5. Election of President** The chair was relinquished to Dr. Kinney, superintendent, for the election of president of the board.

Keith Gillming nominated Pat Bryant for the position of president of the board. Randy McArthur moved that nominations be closed and Pat Bryant be elected president by acclamation. Ron Kuschel seconded the motion. The motion carried: 7-0.

**6. Election of Vice President**

Dr. Kinney relinquished the chair to board president, Pat Bryant for the election of vice president of the board.

Ralph Stahlhut nominated Ron Kuschel for the position of vice president of the board. Ruth Petrov moved that the nominations be closed and that Ron Kuschel be elected vice president by acclamation. Keith Gillming seconded the motion. The motion carried: 7-0.

**7. Election of Secretary of the Board**

Ruth Petrov moved that the nominations be closed and Ron Kuschel be elected by acclamation. Ralph Stahlhut seconded the motion. The motion carried: 7-0.
